ŁAKT ACADEMY REGULATIONS

 \mathbf{A}

- 1) The ŁAKT Academy is a member of the Polish Traditional Karate Union (PUKT), which is a member of the World Traditional Karate-Do Federation (WTKF).
- 2) The training year lasts from September to June each year.
- 3) Prospective Members of the Academy must fill in a membership application and pay a one-time joining fee of PLN 50.
- 4) The membership fee is collected for the training months on a monthly, quarterly, semester or annual basis. The fee may be changed by the decision of the Board of the Academy.
- 5) The monthly fee must be paid before the first training session in a month. Members who did not pay the fee cannot participate in classes.
- 6) All persons participating in ŁAKT classes must have valid medical certificates from a family doctor or a specialist in sports medicine. Members who do not have the certificate cannot participate in classes.
- 7) The ŁAKT Academy provides the training space and qualified instructors.
- 8) The ŁAKT Academy is not responsible for items left in the changing room.
- 9) Each instructor must conduct classes on the agreed days and in the hours, except for holidays and other statutory bank holidays. During "long weekends/Bank Holiday weekends" or Christmas/Easter breaks classes may be held at different times. Members will be informed with sufficient notice. If a class is cancelled by an instructor due to a disease, participation in a competition, training or other chance occurrences, a Member can participate in classes with another group at a time of their choosing.
- **10)** ŁAKT Academy Members **must have a personal accident insurance** (to be bought independently or through the Academy, at the beginning of the season).
- 11) If a Member is absent from classes, he/she can take part in classes with other groups during the following month. The membership fee must be paid even if a Member is absent.
- 12) Any matters not regulated in the regulations are governed by the ŁAKT Academy Charter.
